Tracking the momentum, markets should hold above 8350 level which acts as a major support near 8350 and resistance is near 8480-8500 in near terms.

Global Market: US stocks fell on Thursday, continuing to pull back from the post-election rally, on investor caution ahead of Donald Trump's inauguration as president on Friday. The Dow fell for a fifth straight day, its longest losing streak since just before the November 8 US election. Still, Trump's swearing-in will mark one of the best performances for stocks for any presidential transition period of modern times. The S&P 500 is up 5.8 percent since the vote.
