AGI Infra has recently touched its crucial trendline support near ₹1,176.40, reinforcing the strength of its ongoing uptrend and signaling a continuation of bullish momentum. The stock has been maintaining a strong structure, consistently forming higher highs and higher lows, which highlights robust accumulation and investor confidence.

Momentum indicators are supportive, with RSI (14) on the daily charts placed around 61, indicating healthy strength and ample room for further upside. The stock faces immediate resistance around the ₹1,210 zone, and a sustained move above this level could trigger a sharp rally. On the downside, strong support is visible near ₹1,130, while traders should keep a strict stop-loss at ₹1,040 to manage risk. Overall, the technical outlook remains strongly bullish, with the potential to scale higher levels. If momentum continues, the stock could move toward ₹1,500 and above, offering a favorable risk-reward setup for positional traders.
