Nykaa (FSN E-Commerce Ventures Ltd) has registered a decisive breakout above ₹257.15, accompanied by a sharp surge in volumes, signaling strong bullish momentum and renewed investor interest. The stock has decisively emerged from its consolidation phase, confirming a robust trend reversal on the charts. It continues to trade comfortably above its key short-term moving averages, reinforcing strength in the uptrend.

RSI (14) is trending positively without entering overbought territory, reflecting healthy momentum buildup. The price structure now exhibits a clear higher-highs and higher-lows formation, indicating a sustained bullish continuation pattern. Going forward, sustained trade above ₹257.15 could open the gates for targets of ₹280 and ₹295 in the near term, with ₹320 as a medium-term objective. On the downside, ₹240 remains strong support. Overall, the trend remains bullish, and dips toward ₹250-₹255 should be viewed as fresh buying opportunities for positional traders.
